

### Message from the Management +

In 2013, President Xi linping proposed the Belt and Road Initiative (the BRI) with a purpose of promoting global cooperation, common development and prosperity. The year 2023 celebrates the 45th anniversary of China's reform and opening-up and the 10th anniversary of the BRI. Over this decade, AVIC INTL, as one of the leading forces of China's going global enterprises and carrying the mission of bringing China's aviation industry to the world, has launched high-standard, sustainable projects in countries involved in the BRI (BRI countries) to improve local people's well-being and explore into new paths and new modes for win-win international cooperation.

Over this decade, the BRI, an epoch-making initiative, rewarded us with a leap-forward in economic growth. Guided by the "Air Silk Road" action plan of Aviation Industry Corporation of China (AVIC) and centered on the development of overseas public utility and aviation infrastructure, we made practical efforts to expand overseas markets and secure operation stability and reported much greater percentage of international businesses. Referring to top standards, we spared no efforts to achieve highquality development in core businesses such as airport facility construction, vocational education, cement projects, overseas power projects and transportation. So far, AVIC INTL has organizations in 58 foreign countries/regions and serves customers from over a hundred countries/regions. As a pragmatic player in BRI development, we are doing our part in boosting the high-quality economic growth of BRI countries.

Over this decade, we were committed to the connectivity between BRI countries. Since AVIC launched the Air Silk Road plan, we focused on the development of aviation infrastructure by kicking off over 300 transportation projects and projects for public well-being in more than 20 BRI countries. The 154km "Northern Theater A09 Highway Project" delivered in 2013 opened up the north-south traffic artery in Sri Lanka. The A4 Road project in Kenya, put into operation in July 2022, shortened the journey from three to 1.5 hours, along which large-scale settlements and bazaars were formed in Posta, Suguta and Kisima towns, significantly smoothing the export and transportation of local livestock (cattle and sheep) and agricultural products.

Over this decade, we brought multiple benefits to residents of BRI countries and achieved win-win results. AVIC INTL takes high-quality projects as the hard support and local talent training as the soft support. So far, it has built or upgraded 180 occupational schools in countries including Kenya, Ghana and Gabon that foster over 20,000 teachers and students a year. The employment rate of technical talents from the schools reached higher than 80%. The Africa Tech Challenge (ATC) has been successfully held for eight sessions. Through the training-competition operation, technical talents specializing in regular machine work, digital machine work, reinforcing steel bar and concrete are selected. This program effectively improves local young people's occupational skills, setting a new mode for Chinese central enterprises to perform their corporate social responsibility (CSR) abroad.

Over this decade, we were committed to low-carbon development in BRI countries. We established the mechanism for comprehensive environmental protection, the leading group for energy efficiency and environmental protection, as well as corresponding management organizations to define specific responsibilities to this regard. We adopted streamlined management and waste-reduction management, enhanced identification of contamination factors, and introduced advanced production equipment to minimize waste water, waste gas and discards and help mitigate local environmental pollution. We adhered to safeguarding local eco-environment and practicing philanthropic programs in order to help achieve harmony between human and nature.

Moving ahead against all challenges. Pursuant to the BRI, we will continue to adhere to the development philosophy of "digitalization, marketization, internationalization, and rule of law", spare no efforts to boost high-quality development and economic growth, and make greater contributions to the economic development and public well-being in BRI countries/regions. Keeping pace with China's going global strategy, we will give full play to our advantages in the aviation sector to support the connectivity campaign and serve the people involved in this belt of development and road to happiness.

### Ethiopia | The largest five-star hotel in Africa

On May 5, 2023, Ethiopian Skylight Hotel phase II constructed by China National Aero-Technology International Engineering Corporation held grand opening ceremony, marking that the largest five-star hotel in Africa was put into use. The project, covering a floor space of about 80,600 square meters, includes 287 queen-size bed rooms, 287 double rooms, 26 suites, 26 two-room apartments, 11 three-room apartments, a 1,200 m<sup>2</sup> banquet hall, a 12,000 m<sup>2</sup> underground parking area, and supporting facilities, which, together with the 373 rooms delivered in Phase I on January 1, 2019, makes Ethiopian Skylight Hotel the largest five-star hotel complex in Africa.

The expansion and upgraded service facilities of the hotel would further uplift Ethiopia's service level, create more local jobs, and attract more international tourists to boom local tourism.



### Uganda | Technical training and engineering machinery project

This project, financed by the Export-Import Bank of China and undertaken by AVIC-INTL Project Engineering Company, involves the design, construction, and equipment (including engineering machinery and other machinery equipment) of a technical incubation center and design, construction, equipment, faculty training, and after-sale maintenance (covering seven disciplines, including machining, electrical and electronic engineering) of a skill development center. After its completion, the project will remarkably facilitate technical training in Uganda's capital and western region and foster up to 1,500 skilled talents per year, to relieve local employment pressure and provide great support for local talent training and technical development.

### Laos | Modern agricultural park project

The project, co-developed by AVIC INTL Beijing and partners together with the Ministry of Agriculture and Forestry of Laos, serves as a comprehensive state-level modern agricultural park carrying such functions as a national grain reserve, national agricultural product distribution center, agricultural research and training, agricultural processing and storage, logistics and transportation, and agricultural product and machinery display and trade.

The agricultural part will be connected with the China-Laos Railway via a dedicated railway for direct cargo transport. As the China-Laos Railway has been put into operation, the park will stand as one of the first key demonstrative parks of China-Laos modern agricultural cooperation, as well as Laos' agricultural product export base and an inland port of the Southeast Asian agricultural product logistic hub, bearing vital significance to Laos' agricultural modernization in the future.

### Kenya | The National Youth Service Phase II

Funded by concessional loans from the Chinese government, the project provided the National Youth Service with 289 sets of 33 types of large-scale Chinese engineering equipment and vehicles, as well as specialized technical services, skills training, operational support and other professional assistance, with a focus on further elevating skills training for Kenya's younger generation. Through the project, the National Youth Service undertook construction of multiple roads, housing, dams and border facilities across Kenya, assisting the Kenyan government in carrying out diverse infrastructure projects throughout the country. This helped reinforce Kenya's "hematopoietic capacity" and elevated the country's level of skilled talents.

The project is co-financed by the African Development Bank and the government of Tanzania, and AVIC-INTL Project Engineering Company undertakes 60 km section out of the total 112 km road. As one of the largest highway projects in Central and East Africa, the project is expected to remarkably facilitate regional transportation, boost trading and production of agricultural and industrial products, and improve local living standards.

During his visit to the project, Godfrey M Kasekenya, Deputy Minister for Works and Transport of Tanzania, praised the project team for the high-quality mobilization of staff, equipment, and materials, and extended appreciation to AVIC INTL for employing and training local residents and helping fix roads for local villagers.

Zambia | Ndola International Airport project

This stands as an instrumental cooperation project between the Zambian and Chinese governments under the BRI framework. AVIC-INTL Project Engineering Company serves as the general contractor of design and construction. The construction includes a 3,500-meter code E runway, a 12,000-square-meter modern terminal, and supporting facilities. After its completion, the airport will be able to receive large passenger aircraft, such as Boeing 777, and launch flights to large hub airports in Dubai and Istanbul.

Execution of the airport project will greatly improve Zambia's air transport capacity, boost its economy, and accelerate its industrialization and modernization. In addition, the delivery of the project uplifts Zambia to a higher position in the international aviation sector and releases far-reaching impetus on the bilateral relations between China and Zambia as well as the all-round cooperation between China and African countries.

The aircraft spray painting & maintenance hangar in Ethiopia, designed by China Aviation Planning and Design Institute (Group) Co., Ltd. (AVIC CAPDI) and constructed by China National Aero-Technology International Engineering Corporation, was completed and delivered. It is the largest and only one of its kind in Africa.

AVIC INTL and Angolan Ministry of Transport signed the EPC contract on Luanda New International Airport. The project was financed by ICBC and CITIC Bank and insured by China Export & Credit Insurance Corporation. The terminal buildings applied mature energy-saving technology and advanced BIM technology to reduce energy consumption, making the IT-based airport safe, green and energy efficient.

AVIC INTL Beijing signed the UAE JSW waste heat power generation project, which, upon completion, was expected to lower the cement factory's power consumption by 35%, save 40,000 tons of standard coal per year, reduce CO2 emission by 90,000 tons per year, settle down over 90% of dusts during clinker production. Its economic and environmental benefits highly agreed with UAE's 2050 carbon neutrality objective.

The A4 Road in Kenya was completed construction and open to traffic as planned. The road connects the capitals of Laikipia and Samburu counties, halves the drive hours between the two places, and facilitates the sale and transportation of local cattle, sheep and other livestock and agricultural products. Dams built along the road solved the difficulties of local residents in water use. With the road, the local wildlife park Mugie Conservancy has attracted more tourists thanks to convenient transportation. This development has also boosted local employment.



The south Sri Lanka expressway extension project, a key BRI project undertaken by China National Aero-Technology International Engineering Corporation and financed by the preferential export buyer's credit funds from The Export-Import Bank of China, was open to traffic. It would remarkably shorten the journey from Colombo to Hambantota, facilitate passenger flow and logistics between the ports and the trade zone and revitalize the country's economy. From project approval to completion, the project aiming at harmonious development objectives of "green, ecological and environmental protection" gave high priority to protection of 'local wildlife and natural environment by making careful planning according to local geography and wildlife habitats and migration.

On the African continent, a special and warmhearted contest, Africa Tech Challenge, or ATC in short, is lighting up countless young dreams. In May 2014, Premier Li Keqiang inscribed "The hope of a country relies on the employment of its youth." ATC is an active response to and implementation of the appeal.



### Skill trainings light up young African dreams

ATC is one of the series of activities themed "Love Kenya" supported by the Embassy of the People's Republic of China in the Republic of Kenya and Economic and Commercial Office. It is an overseas CSR activity initiated and fully funded by AVIC INTL, and jointly hosted with the Ministry of Education of Kenya. The annual event has been held eight times successfully since 2014. It covers vocational skills in several professional fields. Excellent students with prominent performances in the contests are rewarded with chances to study in China. Winning institutions are awarded with "orders from China" to upgrade the integration of teaching and industrial chains and realize the vision of "Made in Africa" .

#### Innovation supports cultural and educational exchanges between China and Africa

ATC provides young Africans with a stage to join the world, and lays a solid foundation for China-Africa cultural and educational exchanges.

The 8th ATC focused on the field of mechanical engineering and showcased many highlights. Compared with previous competitions, the 8th ATC had both online and offline competitions running in parallel. The CNC machining training and competition were held offline at the Technical University of Kenya, while the mechanical drafting and CAD application design training and competition were held online through the AVIC INTL Vocational Training Online Platform. This online platform enabled functions such as remote live training, recorded training, assignments, exams, and competitions, allowing students from different countries and cities to participate in the training simultaneously, enabling more students to benefit.

As of the 8th competition, 1,292 teachers and students from 10 countries - Kenya, Cote d'Ivoire, Egypt, Ethiopia, Tanzania, Uganda, Gabon, Ghana, Zambia and Zimbabwe - have participated in ATC's skills training and competitions. ATC provides opportunities for students to receive scholarships to study in China. So far, 24 students have received this honor.

To promote China-Africa cultural exchange, the ATC, in cooperation with the Confucius Institute at the University of Nairobi, organized events on Chinese culture, where students experienced Chinese tea culture, Chinese Zither (musical instrument), facial makeup in operas, calligraphy, letter press and xylograph.

ATC not only echoes the appeal "The hope of a country relies on the employment of its youth", but also demonstrates Chinese enterprises' responsibility "go beyond commerce for a better world". Remaining true to its founding aspiration and the expectations upon it, AVIC INTL will continue its efforts to explore new ways of overseas CSR fulfillment, provide young Africans with opportunities to learn occupational skills, platforms to open their views and ways to apply the skills they had learned, so as to foster new technical talents for the vast Africa continent in a new era. AVIC INTL's efforts on ATC will bring long benefits. The program will continue to light up young Africans' dreams and showcase AVIC INTL's outstanding contribution in terms of overseas social responsibility.







The Jomo Kenyatta International Airport (JKIA) Phases II and III reconstruction and expansion projects in Nairobi, undertaken by China National Aero-Technology International Engineering Corporation (KENYA), have increased the annual passenger throughput of the airport from 2.5 million to 9.3 million and the number of aircraft parking spaces from 26 to 45, making it the most important aviation hub of Kenya and the busiest airport in East Africa.

### Djibouti | Comprehensive hospital project

The comprehensive hospital project undertaken by AVIC INTL Beijing was located in Djibouti, the logistic center in the Horn of Africa and a portal of the 21st Century Maritime Silk Road. The hospital covers an area of 30,000 square meters and a floor space of 23,000 square meters, and has 151 beds. It is a comprehensive hospital capable of internal medicine, surgery, ophthalmology, otolaryngology, pediatrics, gynecology and obstetrics, neurology and laboratory. After completion, it will be the largest hospital in Djibouti with the highest level of medical service and most complete high-end medical equipment, and will sharply improve the medical service level in the country. Capable to receive 200,000 patients a year, the hospital will remarkably mitigate Djibouti's shortage of medical resources, and local residents won't have to seek medical treatment in other countries. The hospital will significantly improve local living conditions. This project of Djibouti's national health care strategy included in its 2035 Vision is commended the "crown" of the public health system by president Ismail Omar Guelleh.

The project is located in Westlands, a core business district in Nairobi. It occupies an area of 30,000 square meters and the construction area reaches 300,000 square meters. GTC is an urban complex comprising a luxurious five-star international hotel, an AAA-level super high-rise office tower, executive apartments, and a boutique mall.

The office building, which is 184 meters high and has 42 floors, is expected to be an office cluster of Fortune Global 500 companies in Kenya, develop into Nairobi's new hub of finance, information and talent, and inject fresh vitality into the economic growth of the country. The JW Marriott Hotel tower, which is 145 meters high and has 35 floors with 317 guest rooms and 51 apartments featuring luxury service, will be the most luxurious hotel in Kenya and elevate the country's tourism infrastructure. The four high-end executive apartment buildings, each with 28 to 32 floors, include four commercial floors as an integral commercial facility of the complex. As a high-end investment project of AVIC INTL in East Africa, GTC also represents the business model combining investment with operation initiated by a Chinese company in East Africa. Its development and operation have created more than 4,000 jobs for Kenyan people, attracted foreign capital, created business opportunities, and improved the business landscape and economic development in the country.

### Kenya | Joint investment and development of flagship project

Case

China National Aero-Technology International Engineering Corporation (KENYA) has proactively explored new business arenas and industrial ecosystems, and explored an investment-construction-operation business model through cooperation with other Chinese enterprises. It has established investment joint venture with leading Kenyan enterprise and conducted close collaboration with South African capital to produce more economic benefits for Chinese enterprises' outbound direct investment projects, and deepen their localized operation and influence.

Since 2013, the Company has worked with Kenya's largest listed company Centum and Chinese company Jiangxi Water & Hydropower Construction Group Co., Ltd. to jointly invest in, construct and operate the Two Rivers urban complex. Covering 102 acres in the core diplomatic area of Nairobi, the Two Rivers urban complex project is just 5 kilometers from the United Nations Office and many embassies, and 30-minute drive from downtown Nairobi. The project, the largest urban complex in East Africa, integrates theme parks, shopping plazas, cinemas, hotels, banks, apartments and office buildings. The shopping mall covers an area of about 60,000 square meters, and a large number of local and international brands, such as Carrefour, Burger King, and LC WAIKIKI, have settled in. The commercial office building, with an area of about 20,000 square meters, is home to a number of foreign embassies and consulates and well-known investment companies.

### Kenya | Karimenu water supply project

The Karimenu II dam water supply project is a flagship project of Kenya Vision 2030, including a 59-meter-high clay core rockfill dam, a 70,000 m3 water treatment plant, and the design, procurement, and construction of the water pipes from the plant to Nairobi and surrounding cities.

The project marks the implementation of China's BRI strategy in Kenya and serves as a driver for the export of Chinese equipment and technology. By hiring local employees and procuring local materials, the project creates many jobs for local residents while stimulating the economic growth of neighboring counties. Furthermore, it lays the foundations for Kenya's "four major programs," namely the development of its manufacturing industry, health care, food safety, and housing.

The project has entered the conclusion stage and begun to supply water. It significantly improves the water supply for Nairobi, the capital city, and its surrounding cities, benefiting more than a million residents. Widely covered by various media, the dam project reported the best progress of the Kenyan Ministry of Water, Sanitation, and Irrigation, receiving a high degree of good attention and commendation from the top level of the Kenyan government.

The 10th of Ramadan City railway project was constructed in strict compliance with European and other international standards. Besides, it was an important step towards applying Chinese design, Chinese plan, Chinese equipment and Chinese technology to international standards and international project management procedures. Based on several CFD argumentation and simulation, our technicians built a set of ventilation system for public areas in railway stations, which is energy-saving, highly efficient and adaptive to local features and practices. The project for the first time adopted centralized mechanical and electrical control, which applies internationally advanced face recognition and smart test functions to the video surveillance system and was recognized by Egyptian safety authorities. It was also the first application of European standard for dual UPS, dual busbar centralized weak current power supply system in a BRI transportation project.

## ⊘ Mutually beneficial cooperation in safe production +

We always give top priority to safety production in overseas projects. We took multiple measures, including formulating safe operation specifications, enhancing safety training, regular equipment checking and maintenance, and implementing risk control, to establish and enforce rational safety management system and safeguard life and health of employees and stakeholders.

### Perfect normalized emergency response mechanism for safe production

Over the decade, AVIC INTL constantly reinforced emergency management in production safety, and continued to perfect safety management system to elevate safe production management level. It formulated and improved the Risk Appraisal and Control Procedures for Hazard Identification and the Safe Production Control Procedures to help in risk screening and safe production control. It also developed the Emergency Preparedness and Response Procedures to stay prepared for unexpected events and disasters and minimize possible casualty and property loss.

### Put people first, raise employees' safe production awareness

For a decade, AVIC INTL has been committed to the value "People-oriented, Responsibility, Partnership, Innovation, The unity of knowing and doing". It put employees' health and safety at the first place to build a "Happiness Station" for them.

In terms of safe production training, AVIC INTL overseas subsidiaries introduced an all-round occupational training program to project development processes. In addition to regular technical trainings and oneon-one assistance, they also organized lectures and trainings on safe production, occupational health and management ability. During the construction of the RWC264 Road project, a comprehensive vocational skill training plan was introduced, which has fostered a group of engineering technicians of international level. Highlighting occupational safety and health awareness, the company has effectively prevented safety accidents and casualties, and safeguarded the safety and health of local employees.

Making full use of local resources, it was committed to localized employment to upgrade local residents' employability and offer them competitive and sustainable jobs. The Company actively involved in overseas public welfare programs and focused on local community development and people's wellbeing, making great contributions to the sustainable development under BRI framework.

### Promote vocational education to make dreams come true

Carrying the Chinese wisdom "teaching people how to fish rather than giving them fish", AVIC INTL built up the brand of ATC to help long-term comprehensive development of local talents, giving hope to local youth that "skill changes fate" and bringing every capable talent opportunities and possibilities. Vocational education programs kept expanding. More than 180 vocational schools have been built or renovated to foster 20,000 teachers and students. The employment rate of graduates of high-level trainings reached over 80%.

Cote d'Ivoire | Seven vocational training schools Case

The Cote d'Ivoire vocational training school project was designed, constructed and equipped by AVIC-INTL Project Engineering Company, who also assisted in school operation. Under the project, seven vocational training schools have been built in seven major cities to offer courses of 14 categories, including machining, electronics and electrotechnics, and automobile repair. The schools are capable to train about 6,000 students a year, which would help improve the country's vocational education in a long run, and provides a talent reserve for the country's economic development.

Gabon | "The vocational training center is an icon"

Starting in 2011, AVIC INTL, backed by the massive quality vocational education resources in China, worked with the Ministry of Employment, Public Service, Labor, and Vocational Training of Gabon to design and implement a vocational training project adapted to local features, covering 12 disciplines, i.e., machining, electrical and electronic engineering, auto repair, welding, iron works, refrigeration, civil engineering, engineering machinery operation and maintenance, agricultural machinery operation and maintenance, carpentry, IT, and aviation service.

So far, the vocational training project in Gabon has registered over 1,000 in-school students and fostered over 60 local teachers in total. The project not only functions as an effective solution for Gabon's intense social conflicts due to the shortage of talent and the high unemployment rate among young Gabonese but also injects driving momentum into the country's modern industrial development. Gabonese president HE Ali Ben Bongo Ondimba has restated on social media that "This is an important approach to our industrial development. The vocational training center is an icon."

### Ghana | A Model of China-Ghana Cooperation in Vocational Education

The vocational education project in Ghana upgraded and transformed 23 local colleges and polytechnics, providing a full range of services including master planning, curriculum design, laboratory and training facility construction, equipment provision, teacher training, and after-sales support. This covered five disciplines: electronics and electrical engineering, mechanical machining, civil engineering, automotive repair, and welding. The project has the capacity to train about 30,000 people annually.

In November 2019, the Vice Premier of China's State Council attended the project's commencement ceremony and remarked: "China-Ghana educational cooperation has achieved remarkable results. Developing vocational education in Africa, providing vocational skills training for African youth, and cultivating high-caliber workers and technical professionals for African countries, not only helps resolve employment issues but also enables them to make greater contributions to social development, which is of tremendous significance."

Jin Yetao joined AVIC INTL in 2011. He spared no efforts in implementing the Belt and Road Initiative with practical actions, innovative thinking and brave exploration. Jin took charge of the Kenya College and Technical School Upgrading Project, which is dedicated to training Kenyan vocational and technical talents, facilitate Kenya's industrialization progress, and strengthen China-Africa people-to-people exchanges and cooperation. On March 10, 2019, Jin died on his way to Kenya for the execution of the next phase of the project. Jin devoted his whole life to his beloved career of vocational education in Africa where he strenuously worked.

The Jin Yetao Scholarship was established spontaneously by employees of AVIC-INTL Project Engineering Company on January 25, 2021, in memory of Mr Jin Yetao. In 2022, it started to donate Ksh 1 million (about USD 10,000) annually to Hospital Hill Secondary School on Red Hill Road, Nairobi, to support 10 to 20 students who excel academically and face financial challenges. By providing financial aid, the scholarship helps these students continue their studies and provides them with the opportunity to change their futures.

#### Intensify employment of local communities

Over the decade, AVIC INTL was committed to boosting all-round local development throughout project processes. Through localized operation and project management, it appropriately coped with cross-culture challenges to overseas project operation and created many local jobs.

The project team of south Sri Lanka expressway extension Lot I consisted of over 700 Chinese managers and over 4,400 local employees, the latter accounting for about 87%. According to available data, the project, since the mobilization phase, has created 33,912 jobs, of which 14,204 were direct and 19,708 were indirect employment opportunities. Besides, the project has trained a large number of management and technical talents for Sri Lanka, including a total of 728 excellent local engineers and managers and 7,722 local technical workers. Most of the local engineers and managers have been reemployed in port city, central expressway and other large projects.

China National Aero-Technology International Engineering Corporation (KENYA) registered over 90% of local employees in road and bridge projects. For example, the RWC264 highway project (under construction) has 165 local and only six Chinese employees (28:1), indicating a localization rate of 96%. Undertaken by China National Aero-technology International Engineering Corporation, the Dr. Antonio Agostinho-Neto International Airport (Luanda New International Airport) hired about 1,600 local constructors, technical managers and interpreters, and would hire more as the project progress.

### Kenya | Localized recruitment strategy deepens

Case

AVIC INTL Beijing (E.A.) implemented localized operation and development strategy. It had 85 local employees, accounting for 90% of the total. Open competitive recruitment process encouraged local employees to compete for the leadership positions. The company has had a number of local management talents, including sales supervisors, technical supervisors and service supervisors.

At the end of 2017, China National Aero-Technology International Engineering Corporation (KENYA) attended a job fair targeted at Kenya university students, which was organized by the Confucius Institute at the University of Nairobi and co-hosted by KCETA and Kenya China Chamber of Commerce, seeking to recruit talents in fields of civil engineering, survey measurement, laboratory test, HR management, marketing, administrative assistant, legal affairs and interpretation. The company received more than 300 CVs, and over 20 passed the preliminary selection.

### Kenya | Rebuilt Mathari primary school to ensure educational opportunities for children

Case

In 2015, China National Aero-Technology International Engineering Corporation (KENYA) undertook the zero-profit expansion project of Mathari primary school in Nairobi. The existing school buildings were renovated, and two three-story teaching buildings and a playground, as well as a series of facilities such as 32 classrooms, offices, assembly halls, basketball courts, canteens, kitchens, and washing rooms were built. The project received high attention from local residents and social media during the construction. The company completed the project and delivered the beautiful, well-equipped and child-friendly school in 2017. The new school provided educational opportunities for 1,000 additional children as well as employment opportunities for eight teachers, winning high praises from the local communities.



# Promoting green development, implementing sustainable concepts +

Over the decade, AVIC INTL abode by the green Silk Road concept and actively responded to the carbon neutrality and carbon peaking strategy. It continuously improved its environmental protection system, expanded its green management team and enhanced its green management ability to consolidate the foundation for energy saving and emission reduction. At the same time, the Company actively took part in discussions on green strategy implementing paths and constantly intensified environmentfriendly technical innovation and application to build up AVIC INTL's low-carbon image and green, responsible brand, in order to boost the green development of the BRI.

### Perfect administrative system, strengthen risk prevention and control

AVIC INTL pays high attention to the impacts of its development and operation decisions on communities and environment of BRI countries. To ensure the sustainability of green management, the Company strictly complied with local environmental protection laws and regulations, formulated series of green management strategies and environmental protection rules, and applied the concept of environmental protection to its business activities.

To intensify environmental emergency management and establish the environment warning and emergency response mechanism, the Company developed, improved and rigidly complied with the Environment Emergency Response Plan of AVIC International Holding Corporation as well as other rules, and gradually perfected its environmental risk management system, which enabled it to effectively control and mitigate damages of emergencies to environment, community and the Company's property, setting a strong shield for the Company's green development.

### Explore into environment-friendly technologies, increase inputs into environmental protection

During its overseas development, AVIC INTL gave continuous input into R&D and innovation of environment-friendly technologies to promote application of green technologies and inject technological impetus for green development. It has launched green projects one after another. In 2022, AVIC INTL invested RMB 153 million in energy conservation and environmental protection, and provided 113 training courses on environmental protection totaling 270 hours and covering 10,649 person-times.

Dr. Antonio Agostinho Neto International Airport is the largest international airport project with the most complete functionalities constructed overseas by a Chinese enterprise. The terminal buildings applied mature energy-saving technology and advanced BIM technology to reduce energy consumption, making the IT-based airport safe, green and energy efficient. Buildings in the airport can fully take in natural lights. The screen walls and windows are made of hollowed LOW-E glasses, the exterior walls are applied with thermal isolation materials, and the lighting system uses LED light sources and highly energy conserving products. All these help lower energy consumption to a large extent. Hot waters are exclusively provided by solar power and air-source heat pumps, and waste waters are transformed by advanced sewage and solid waste treatment equipment into reclaimed water for irrigation purpose.

Climatic change is a challenge to all human, and AVIC INTL believes coping with climatic change is part of its responsibilities. We adhered to energy conservation and emission reduction, advocated green operation, and minimized use of resources and waste discharge to lower negative impact on environment.

#### Promote energy conservation management towards carbon peaking and carbon neutrality

AVIC INTL continuously strives to integrate the fulfillment of corporate social responsibilities into all aspects of its production and operational management. A mature implementation model has taken shape, spearheaded by the leadership and actualized through cross-departmental and cross-business collaboration. This consolidated approach lends robust support towards methodically advancing AVIC INTL's social responsibility initiatives, ensuring the company's strategies and operations satisfy sustainable development imperatives.

AVIC INTL has included restrictive energy conservation indicators into its operating performance appraisal system for all member companies and organizations to establish a long-term energy conservation and environmental protection management mechanism featuring supervision, appraisal and incentives. To this regard, it has set up an internal leading group and management organization to identify responsibilities, so as to build an up-down organizational management system, and honestly perform environmental responsibilities. It also took multiple measures to seal green endorsement on the BRI and give sustained support to carbon peaking and carbon neutrality objectives.

### UAE | JSW waste heat power generation project

Undertaken by AVIC INTL Beijing, UAE JSW waste heat power generation project includes building a 15MW waste heat power generation system to make use of the waste heat from the client's 4,000TPD and 5,000TPD cement clinker lines. The project adopts a green energy-saving system that directly recovers waste heat from the cement factory for power generation. It doesn't consume additional fuel, and lowers the cement factory's power consumption by 35%, save 40,000 tons of standard coal per year, reduce CO2 emission by 90,000 tons per year, settle down over 90% of dusts during clinker production. Its economic and environmental benefits highly agreed with UAE's 2050 carbon neutrality objective.

### Sri Lanka | South Sri Lanka expressway extension Lot I

Sri Lanka gives high priority to natural ecology and environmental protection. Its people care much about their ecological and environmental rights. As a genuine "made in China" project, the project, from approval to completion, aimed at harmonious development objectives of "green, ecological and environmental protection", and gave high priority to protection of the country's wildlife and natural environment by making careful planning according to local geography and wildlife habitats and migration. It took "four measures", set several animal paths in the 13.27-km forest reserve to minimize its impact on wildlife nearby the expressway, and ensured the stability of the original ecosystem to the largest extent.

Existing rivers and ditches beside the expressway are  $\gamma$ preserved, which reduces the expressway's flood detention effect and minimize ecological impact.

In flooding areas and soft roadbed areas, viaducts are used instead of earthworks and refilled roadbed. Viaducts take few lands and are ecology-friendly, and reduce earthwork-caused landslide, damage to vegetation and loss of soil.

Safety nets are set all along the expressway and animal paths are built in the forest reserve to shield off wildlife from construction sites and ensure animal immigration.

for environmental All embankments, cuttings and median strips are 100% covered by vegetation, and vegetations on dump yards and lands occupied during construction are restored, making the expressway a picturesque horizon in Sri Lanka.

### Protect biodiversity and ecological equilibrium

AVIC INTL highly approves of and adheres to the Convention on Biological Diversity (CBD), and takes such measures as ecological restoration and surveying habitats to develop target strategies on protecting indigenous fauna and flora. We actively communicated with local environment authorities, and encouraged our employees to take part in environmental protection activities to raise their environment awareness and capacity.

### Kenya | Elephant rescue

On March 1, 2022, an elephant in the local Mugie Conservancy stumbled into a swamp puddle, and fell into a critical condition. At the requests of local authorities, the Conservancy and wildlife protection association, AVIC INTL immediately dispatched professional equipment for rescue. After hours of intense work, the trapped elephant was finally out of danger. The practice was a reflection of the corporate social responsibility of the Company as a Chinese enterprise, and brought it an excellent reputation and good social benefits in the local area.
